Rodeo season is upon us and 4SYRA is happy to be back for the third year. We are looking forward to a successful rodeo season. Attached you will find a membership form, entry forms (please select appropriate one), and minor release. The following **MUST** be completed and postmarked by August 1, 2024 for rodeo #1:

- Membership Application (must be notarized)
- Minor Release (must be notarized)
- Entry Form (note there is a separate entry form for 6U)
- Copy of Birth Certificate
- Payment for Membership
- Payment for Rodeo 1

All checks should be made payable to 4SYRA. Membership checks will be deposited as received. Entry fee checks will be deposited the week of rodeo #1. If you have more than one contestant, you may combine their checks for fees and checks for membership dues together, but please still write two separate checks for membership and entry fees. Any contestant in the 6U must write a separate check for that age group and not be combined with any other age groups!

At each rodeo, you MUST complete your entry form for the next rodeo and place it along with PAYMENT in your labeled folder. Checks will be deposited the week of that rodeo. If you need to leave cash, please give it directly to the secretary. Call-in entries for non-members will be taken the Monday before each rodeo.

Our first rodeo is August 24, 2024 at Marshall City Arena in Marshall, TX. We will begin with the non-competitive 6 & under at 9:00am. All 6 & under will complete their events and the competitive rodeo (age groups: 8U, 9-11, 12-14, 15-19) will follow but will not start before 10:30 am. Depending on the number of entries for 6U, this time may change in the future.

The following will be our fundraisers for the 2024-2025 year along with their due dates:

- Mum Fundraiser (this is the only fundraiser that is not mandatory, but we will give a bonus for the Top Seller!!) Orders Due at rodeo #2, Sept. 7, 2024 and will be responsible for picking up mums at rodeo #3, Sept. 28, 2024.
- Sponsorship (mandatory) each contestant is responsible for a minimum of \$100 worth of sponsors. Due at rodeo #4, Oct. 19, 2024
- Silent Auction (mandatory) each contestant must bring one silent auction item to rodeo #5, Nov. 9, 2024.
- Raffle Tickets (mandatory) each contestant is required to sell 25 raffle tickets totaling \$125, due at rodeo #7, Nov. 23, 2024

Please read the entire rule book and be aware of any rules changes that may have taken place. We will have a total of 10 rodeos plus the finals which will consist of 2 go-rounds. You must enter and pay fees for 6 out of the first 9 rodeos in order to be eligible for finals. We will have a mandatory meeting at rodeo #1 for all contestants and parents!
